

## REGULATIONS ON THE DEBATE CLUB OF THE CASPIAN INTERNATIONAL SCHOOL OF MEDICINE

### 1. General provisions

- 1.1. Debate club "Speaker" (hereinafter - the Debate club) is a voluntary Association of students engaged in the development of tolerance, skills, oratory skills, logic, critical thinking and leadership qualities among students Caspian international school of medicine (hereinafter CISM).
- 1.2. In its activities, Debate club is guided by the Constitution of the Republic of Kazakhstan, regulation CISM, the position of the Student Council, as well as the present regulations.
- 1.3. The activity of the Debate Club is based on the principles of transparency, openness, taking into account the opinions of each member, free discussion of issues, collective decision-making.

### 2. Goals and objectives of the Debate Club

#### 2.1. Goals of the Debate Club:

- 2.1.1. development of talented and initiative youth;
- 2.1.2. formation of socially and politically oriented citizens of the society;
- 2.1.3 development of critical thinking, oratorical abilities, communication skills of club members;
- 2.1.4. development of compromise solutions potentially implemented in practice on the discussed problems;
- 2.1.5. free development of a creative professional personality, individuality, the ability of club members to defend their point of view, convince others, as well as the ability to admit their mistakes.
- 2.1.6. promoting social and professional self-realization of club members.
- 2.1.7. contributing to the development and strengthening of the Kazakh and international debate movement;
- 2.1.8. development and improvement of the game, development and testing of new formats;
- 2.1.9. constant updating of the membership of the club.

#### 2.2. In order to achieve these goals, the following tasks are solved:

- 2.2.1 development of interest among young people and society as a whole in the ongoing socio-political processes;
- 2.2.2. formation of political culture among the younger generation;
- 2.2.3. accumulation of experience and development of a culture of public discussion of socially significant problems;
- 2.2.4. development of the ability to speak confidently and beautifully in front of various audiences, to convince with reasoned arguments, the ability to think logically and to conduct a discussion correctly.

### 3. Areas of activity of the Debate Club

- 3.1. The areas of activity are formed in accordance with the goals and objectives defined by this Regulation and the plan for the educational work of the CMSM.
- 3.2. The main activities of the Debate Club are:

3.2.1. expanding the horizons of the members of the Debate Club, contributing to their accumulation of general and specialized knowledge about modern world, regional and local problems;

3.2.2. additional education and self-education of the members of the Debate Club, as well as the acquisition of knowledge and skills in the field of medicine;

3.2.3. developing a sense of empathy, tolerance, respect for opponents, the ability to listen and hear others, the ability to independently and collectively make decisions;

3.2.4. development of psychological stability, self-belief, positive self-esteem;

3.2.5. development of the ability to see the positive and negative sides of any problem, the ability to think strategically, analyze the situation;

3.2.6. development of cooperation and relations between students and other youth public associations;

3.2.7. attracting new like-minded people to the Debate Club;

#### **4. Members of the Debate Club. Rights and obligations**

4. 1. The members of the Debate Club can be students of the CISM who voluntarily accept the ideas of the debate movement.

4.2. Members of the Debate Club can join teams to participate in debate games, tournaments, forums;

4.3. The rights and obligations of the members of the Debate Club are based on the goals and objectives defined by this Regulation and the regulations of the CISM.

4.4. Members of the Debate Club have the right to:

4.4.1. motivate young people to participate in the debate movement;

4.4.2. develop and support youth initiatives aimed at developing patriotism, tolerance, leadership qualities;

4.4.3. in agreement with the management of the CISM to represent the School of Medicine at games, tournaments, forums, as well as at other public events of this profile;

4.4.4. to form mechanisms for attracting young people to the diverse activities of the debate movement;

4.4.5. make proposals concerning the activities of the Debate Club, and participate in their discussion and implementation;

4.4.6. receive information about the activities of the Debate Club;

4.4.7. freely withdraw from the members of the Debate Club on the basis of their own desire;

4.4.8. to elect and be elected to the coordination bodies of the club.

4.5. Members of the Debate Club are obliged to:

4.5.1. know the present Regulations;

4.5.2. act in accordance with the goals and main objectives of the Debate Club;

4.5.3. take an active part in the work of the Debate Club, planning and holding events;

4.5.4. implement all decisions of the general meeting of the Debate Club members;

4.5.5. comply with the requirements of this Regulation and the obligations assumed;

4.5.6. attend the meetings of the Debate Club members in a timely manner;

4.5.7. be a model for others, lead a healthy lifestyle, do good to people, show feelings of tolerance and respect for one's neighbor;

4.5.8. be responsible for their behavior and actions, recognize the equality of all people, work to improve society;

4.5.9. not to commit actions that violate this Regulation, the ethics of friendly relations, as well as actions that cause moral or material damage to the Debate Club, refrain from activities that contradict the goals and objectives of the Debate Club;

4.5.10 protect your good name and dignity of the Debate Club.

### **5. Management of the activities and structure of the Debate Club**

5.1. The governing bodies of the Debate Club are the Department for Work with students of the CISM and the Curators.

5.2. The activities of the Debate Club are organized by its coordinator, who is elected at the general meeting from among the members for a period of 1 year.

5.3. The powers of the coordinator of the Debate Club extend to:

5.3.1. holding meetings of the general meeting of members of the Debate Club with the right of decisive vote;

5.3.2. representation of the interests of the Debate Club in the Student Council, in the administration of the KMSM.

5.4. The powers of the General Meeting extend to:

5.4.1 determining the development strategy of the Debate Club;

5.4.2 organization and conduct of the election of the coordinator of the Debate Club;

5.4.3 definition of areas of activity.

5.5 The General Meeting is held at least once a month. At the request of half of the members of the Debate Club, or at the request of the governing body, extraordinary meetings and meetings can be held.
